### Extended Parking Rules

- All items must be pre-approved before parking and parking is subject to available space.
- Issued Parking Sticker must be placed on the trailer tongue or vehicle windshield for identification.
- You may only park in extended parking areas. No overnight occupancy is allowed in stored vehicles/trailers.
- Cars and Open trailers (with or without a car) cost \$25.00 per month. Enclosed trailers will be charged \$2.00 per foot per month (with or without a car). Trucks with trailers will be measured including both the truck and the trailer.
- Access to the VIR extended Parking Areas may be restricted on certain events. You must contact VIR Security if you need to arrange access to the VIR Extended Parking area outside of normal operating hours at 434-822-3109.
- Cars and trailers left longer than three days will be charged for a full month's storage.
- All trailers MUST have valid state issued license plates. Trailers with expired registrations are subject to removal at the owners' expense.
- Payment is due in advance at time of storage for designated periods of time. No refunds or prorated parking fees will be given under any circumstances. Payments for open storage dates are initially charged for the first month with following payments made via credit card on an automatic recurring basis. Payments will continue until the vehicle/trailer is removed. It is the owners' responsibility to notify VIR Security Director that the vehicle/trailer is removed.
- VIR does not carry insurance that would cover owner's property parked at VIR and the decision as to whether to carry liability, theft or other such insurance shall at all times remain the decision of the owner of the property parked at VIR.
- VIR shall not be held liable for the theft or for any damage to any vehicle or their contents for any cause whatsoever, including but not limited to weather, rain, wind, hail, flood, vandalism, criminal acts, accidents, relocation or other such loss or damage.
- All parking fees must be paid in full prior to removal of trailer/car. VIR is granted a lien on the trailer/car by the owner until all rental fees are paid in full and VIR is expressly permitted to enforce this lien through self-help remedies.
