



## VIR Camping Policy 1 January 2024

**General Information:** VIR is subject to Title 12, Virginia Administrative Code, Section 5-450 for camping. Each area of VIR approved for camping is identified in this policy designating the camping area and number of campers authorized in those areas. Camping periods start at 6:00 pm on the day prior to an event and end at 10:00 am on the day following the same event. **At the discretion of VIR, times may change depending on the event.** Campers who stay for an additional event are subject to an additional fee for camping/power. **Campers in the paddock must relocate from the paddock if another organization is moving in for the following day.**

Camping periods start at 6:00 pm on the day prior to an event and end at 10:00 am on the day following the same event. **These times may change at the discretion of VIR.** Campers who stay for an additional event are subject to an additional fee for camping/power. During any major event at VIR the fence line camping is deemed as reserved spaces. Any other general camping area is open to spectators at the published rates. During the major events, the area on the right side of the crossover bridge is deemed as **tent** camping only. No motorized vehicles are permitted in the roped-off area at any time during the event. At no time is camping permitted on the False Grid or under the Pavilion.

**General Camping Areas:** General Camping is permitted on unpaved areas of the facility except for reserved camping and areas delegated at VIR discretion. During special events, specific camping areas may be roped off and designated tent only for safety. Premium, Reserved, and General Camping areas and Shower/Restroom Facilities are indicated on the map below.

**Camping Fees:** Prices quoted for camping at VIR are for General/Facility Access events and for Spectator/Ticketed events. All vehicles will receive a pass for camping. General event campers are issued an armband for camping that is affixed to the camper door or in the case of tents to the top front guide line loop. Camping passes must be displayed at all times while on VIR property.

Camping fees do not include the price of admission for spectators. Event tickets and camping fees are purchased online or at the Security Gate House entrance.

General camping is not permitted in the Hog Pen section during Spectator events.

VIR Club Members are entitled to camp at VIR at no charge but may be subject to making reservations depending on the event. See VIR Camping Policy for further details of VIR Club Member Benefits.

You can pay for general admission camping at the gate. To purchase premium or reserved RV camping, call the VIR Lodge office at 434-822-7700 Ext. 300 or 101. The Lodge can also be reached at [lodge@virnow.com](mailto:lodge@virnow.com). General Camping can be purchased on Etix when you make a ticket purchase. Guests making Etix purchases **must print their Camping Pass** and present it at the gate when you arrive for your event.

If you are renting an RV for an event at VIR you "**The Renter**" are responsible for purchasing your camping pass, either online (<https://form.jotform.com/222085167481053>) or through the lodge in advance, and that the company/individual delivering the RV has it and knows the location to put the camper. If this information is not on hand or is unknown the camper will be placed off-property in the extended parking lot, and your responsibility to bring it on site.

Pre-paid and registered RV's can be delivered the day prior to an event in General Camping; Pre-paid and registered RV's rented for Paddock Camping can be delivered after 6:00 pm the day prior to the event. **Placement in the paddock is the responsibility of the RV Renter.** If the RV renter is not onsite the RV

will be placed in an area approved by the Track Renter. RV Renters can enter in accordance with the track admission policy for the day they arrive at the track.

Rental RV's delivered for the Premium Camping or Reserved RV Spaces reserved through VIR Lodging are not subject to the pre-paid fee requirement. It is the renter's responsibility to notify the Lodging Office that a rental RV is being delivered. VIR Lodging contact #434-822-7700, ext 101.

The amount of security needed for overnight camping is at VIR's discretion. Additional security over what is stated in the contract may be billed to the Track Renter. Camping is not permitted in any of VIR's buildings, on the False Grid, or under the Pavilion.

**All campers must depart the facility no later than 10:00 am on the morning after the event they attended is complete. This includes rental campers.**

\*This time may be changed at the discretion of VIR and notification to campers.

### **Administrative Information:**

**Camping:** General Camping is not reserved and is paid for at the Main Entrance. General Camping areas are open to all types of camping with the exception of the wooded area at the Patriot Course and the open area between turns 2-5 **which are restricted to tent only**. Other areas that have restrictions are posted during specific events. VIR is not responsible for removing campers who become stuck or disabled on property. Branns Wrecker Service, (336) 599-1910 can be notified to move/tow campers at owner's request and expense. If a stuck/disabled camper is left on property without notification to VIR Security it may be deemed abandoned and will be removed by Branns Wrecker Service. Camping is not permitted in any building, under the Pavilion or False Grid on the VIR facility.

**Campfires:** Campfires/Ground fires are not allowed. Fires must be contained in a portable and self-contained off-the-ground fire pit. Campers must bring their own firewood; use of VIR Property as firewood is prohibited.

**Electricity:** Camping fees do not include access to electricity. Electrical access is only available in the North or South Paddock. The electrical fee is \$40 and may be purchased when paying for camping. VIR will issue an electrical "Power Band" to be placed on the end of the electrical cord plugged into a VIR power source. Security will periodically check the power stations and will remove any power cord that does not have the proper power band.

VIR Club Members are entitled to one paddock electrical hookup per event at no charge based on availability.

If there are issues with power pedestals contact VIR Security or Maintenance. **Tampering with the pedestals is prohibited.** Please report any damage to power boxes and outlets before you utilize the service **so you are not charged.**

**Fees: Unless paying for camping per night, all camping fees are for a specified track event. Campers, who stay for multiple events in a row, are subject to camping/power fees for each subsequent event for which they stay on property.**

**Garbage Removal:** Campers are responsible to collect all trash and remove it or deposit it in the green trash containers located throughout the facility. Campers are responsible as well, to clean up after their pets.

**Generator Policy:** During designated spectator events VIR recommends all RV's camping on property and using a generator to use an exhaust extension to vent generator exhaust fumes above the RV. The extensions can either be commercially purchased, such as the Gen-Turi systems, or a DIY system that vents the fumes above the RV. This policy also applies to stand-alone generators in camping areas.

**Picnic Tables:** Picnic tables are for everyone's use. Campers are not authorized to move tables from their positions in the camping areas.

**Premium RV Spots:** The premium RV spots in the North Paddock are prioritized for Track Renters utilizing the North Paddock and their Participants during their Event. Renters can rent all of the Premium RV spots for their designated use. VIR reserves the right to rent any unrented Premium RV spots during any event.

**Premium RV spaces** receive one vehicle pass for the facility; Vehicles must be able to be parked within the designated camping space. Reservations for premium RV spots are made through VIR Lodging at 434-822-7700 Ext 300 or 101.

**Sanitation Services:** The recommended vendor for sewage removal is Matthews Sanitation (434) 572-6098 or 434-575-1535. They will come to VIR to pump septic systems for RV owners. A dump station is located in the North Paddock (Premium RV area) however; during designated spectator events, this is off-limits to spectator's campers.

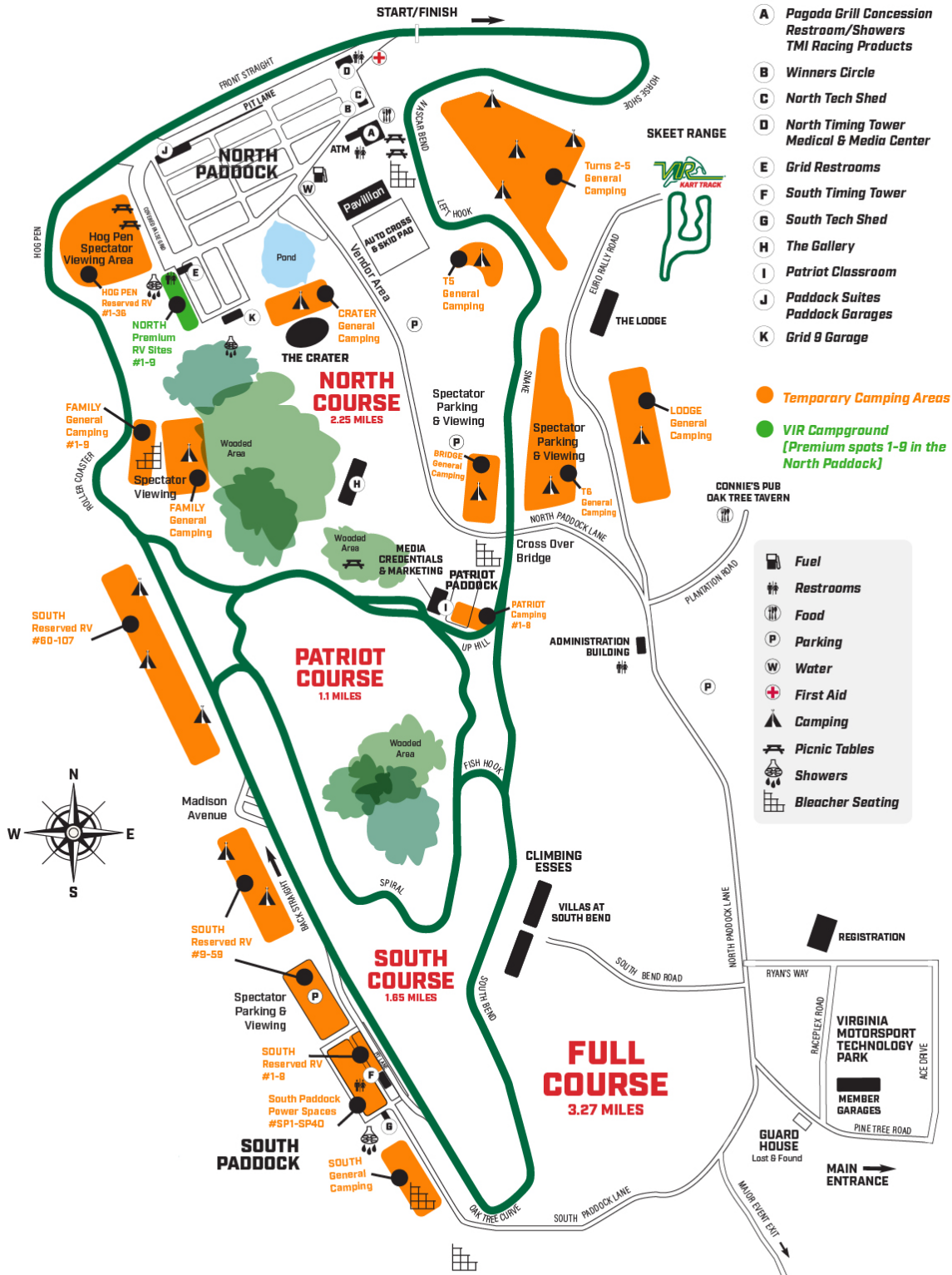
**Showers** – The showers are located in the North Paddock main concession building restrooms, at the North Paddock grid barn, North Paddock Pond camping area, and the South Paddock tech shed. Please be considerate regarding water usage and do not waste water.

### General Camping Map:





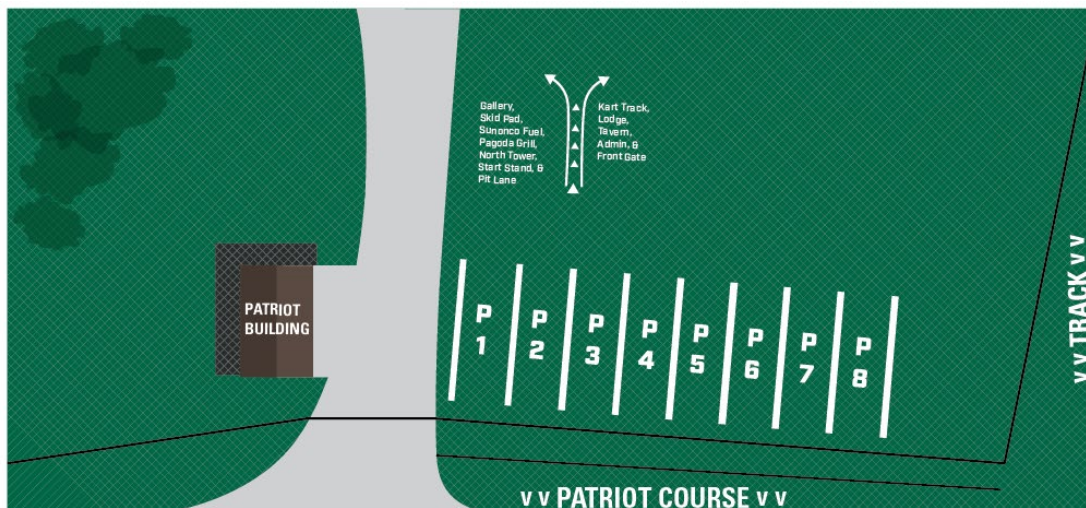

**North Paddock Premium RV Camping:** VIR has 9 Premium RV sites in the North Paddock: These sites are scheduled through Lodging at [Lodge@virnow.com](mailto:Lodge@virnow.com). Each site has power, water, and sewer hookups. Participants have priority for these spots during events. These spaces have a view of the Down Hill Roller Coaster. Check-in time is 6:00 pm.



**The Following Reserved RV Camping Options are available at VIR during Spectator events.** These spaces are all primitive camping spaces, there is no access to Electric, Water, or Sewer unless designated. VIR recommends bringing leveling blocks as not all spaces are level. Prices for these spaces are subject to the Spectator Event pricing and are scheduled through Lodging at [Lodge@virnow.com](mailto:Lodge@virnow.com). Check-in time is 6:00 pm.

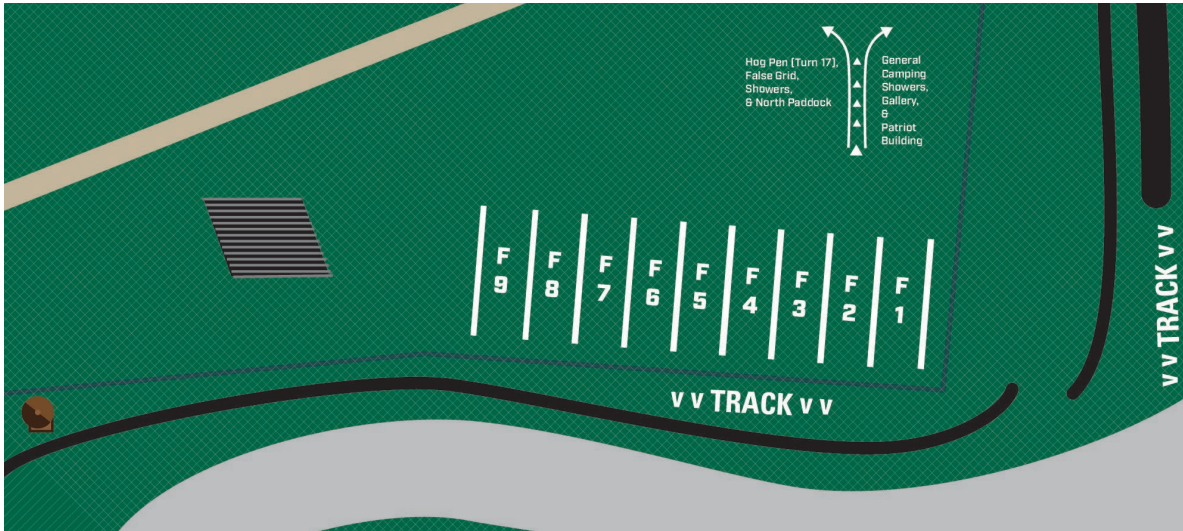
**Patriot Reserved RV Camping:** VIR has 8 RV spaces located in the Patriot Track Paddock. They are located along the trackside fence and are 20' x 40' and generally level. This area is located at the base of the uphill esses and is ideal for viewing the Full, North, Patriot, and Grand Courses.





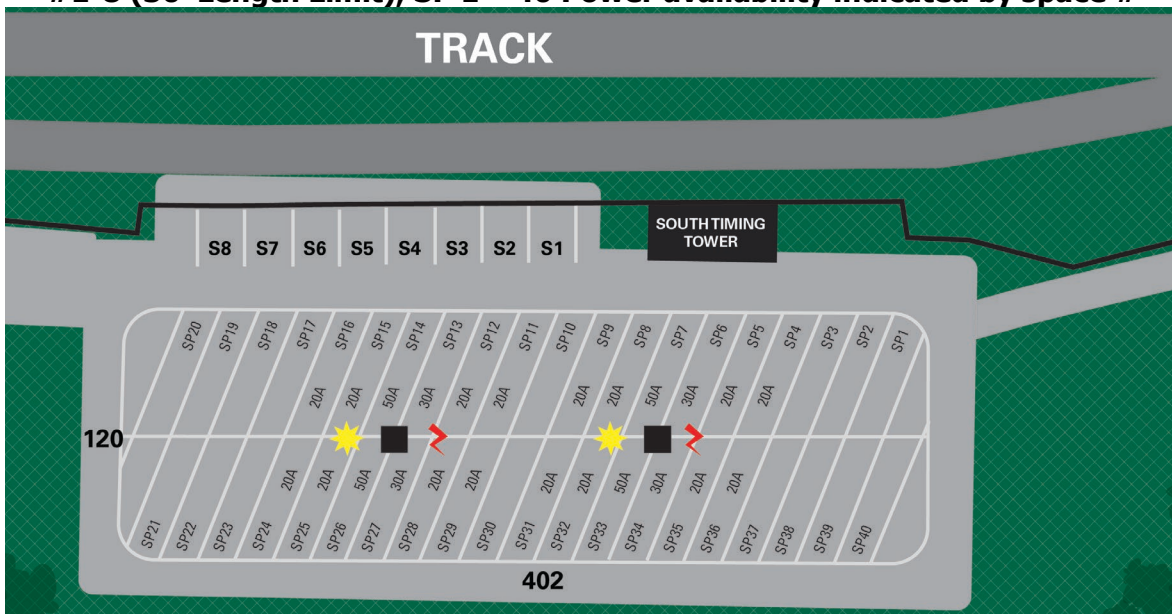

**Family Reserved RV Camping:** VIR has 9 spaces located in the Family Camp Ground reserved for RV's. They are located along the trackside fence south of the Flag Stand and are 20' x 40'. We recommend bringing blocks as not all spaces are level. This area is restricted to the family campground rules: No alcohol or loud music/noise. This area is located at the top of the Down Hill Roller Coaster and is ideal for viewing the Full, North, and Grand Courses.



**South Paddock Reserved RV Camping:** VIR has 150 spaces located in the South Viewing Area (North of the Timing Tower along straight away fence and Paddock). 107 of the spaces (1-107) are along the trackside fence (1-8 are on the blacktop). Each space is 20' wide and some have limited lengths as indicated below. We recommend bringing blocks as not all spaces are level. This area is along the back straight away and is ideal for viewing the Full, South, Patriot, and Grand Courses.

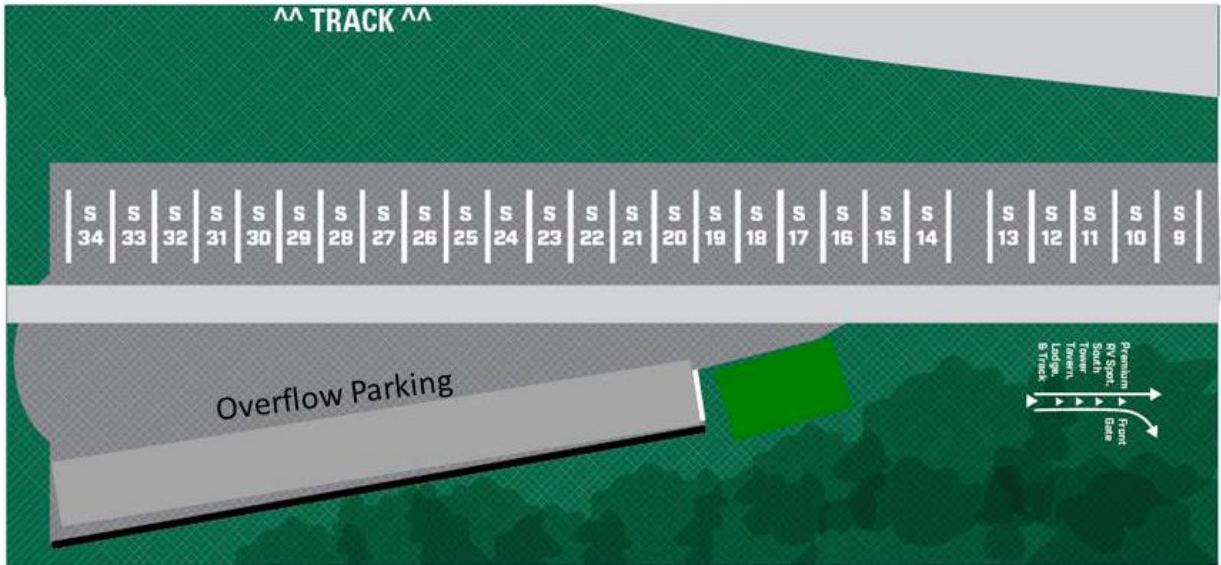

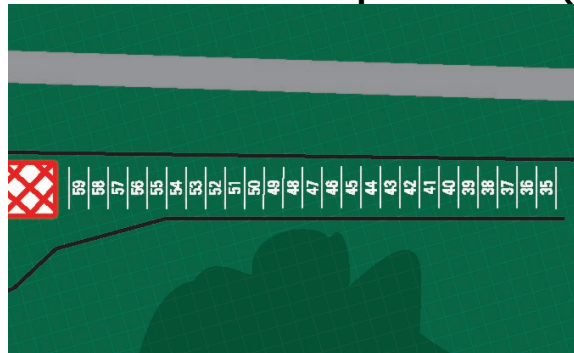

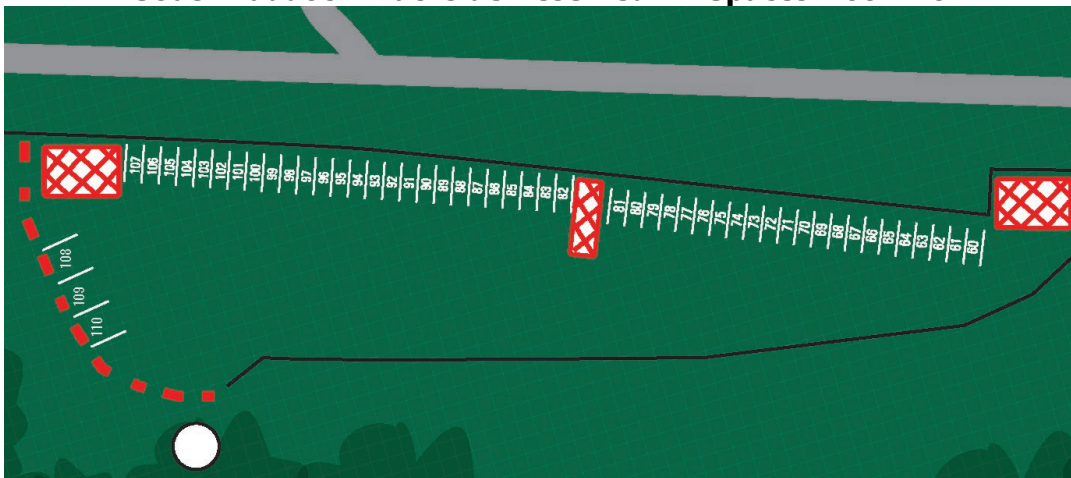
### South Paddock Trackside Reserved RV Spaces #9-34 (#9-17 35' Length Limit)

**Hog Pen Reserved RV Camping:** VIR has 36 reserved spaces located in the Hog Pen (#17) Turn area of the track. 23 spaces are along the trackside fence and 13 spaces are along the hilltop beside the false grid. Each space is 20' x 40'. We recommend bringing blocks as not all spaces are level. This area is ideal for viewing the Roller Coaster Section of the Track. Access to the Hog Pen is taking the gallery access road, through the Family Camping area, and down the hill.
