

**Unregistered Vehicle Policy** – Golf Carts, ATVs, Motorcycles, and other unregistered vehicles as defined via VA Sc.46.2-100, must be registered with VIR. Each vehicle must have a minimum seat height of 24 inches, have operable lights, brakes, and horn (if so equipped), and have an Original Equipment Manufacturer hand-controlled steering and braking system. All Operators must be over 16 years of age and possess a valid state driver's license. Homemade vehicles of any type, skateboards, hoverboards, or single-wheeled vehicles are not permitted for use at VIR.

Owners can purchase an Unregistered Vehicle Pass online and the link below for \$30. Unregistered Vehicle Passes sold onsite are \$35 and both are valid for the remainder of the current season.

Golf Carts rented through the VIR Vendor are not subject to Registration.

Unregistered Vehicle owner, operator, and/or entrant:

1. Acknowledges and agrees that the vehicle shall be operated in compliance with the vehicle manufacturer's operating instructions and/or industry standards, including those regarding riding/driving position and number of passengers, and has a **minimum seat height of 24 inches. Skate Boards, Scooters, hoverboards or single wheeled vehicles are not permitted for use at VIR**
2. In accordance with the Code of Virginia, Title 46.2-915.1 All Unregistered Vehicle Operators shall wear a helmet while operating the vehicle anywhere on VIR property, **which is the responsibility of the Operator**. Passengers are only permitted on vehicles designed and equipped to be operated with more than one rider.
3. Hereby **releases VIR from any liability** and assumes full risk and responsibility for any bodily injury, death, or property damage arising out of or related to the use of said vehicle, whether caused by the negligence of the owner and/or their operators, pedestrians, Racetrack, Unregistered Vehicle operators or otherwise.
4. Acknowledges and agrees that all operators of said vehicles shall be at least **16 years old**, have a valid state-required driving license, and carry adequate liability insurance applicable to the operation of their Unregistered Vehicle(s) and that all operators shall provide such licenses, proof of insurance and other applicable credentials upon the request of a Racetrack or event official. **If a Golf Cart, ATV, Motorcycle or other unregistered vehicle displays a state-issued license plate, a valid registration card and insurance card must be on hand with the vehicle to be exempt from the Paddock Vehicle Pass requirement.**
5. Hereby acknowledges that the use of motorized or electric Unregistered Vehicles is dangerous and involves the risk of serious injury and/or death and/or property damage.

6. Acknowledges that all Unregistered Vehicles **MUST** display the owner's current Unregistered Vehicle Pass provided by VIR on the front left (Driver's) side of the vehicle. **Stickers are not transferable.**
7. Agrees that the Unregistered Vehicle will be operated in a responsible manner and according to all additional Racetrack regulations and instructions including, but not limited to, posted speed limits, hours of and allowed locations for operation. **Off-road areas are off-limits without written permission from VIR.**
8. **Acknowledges the facility-wide speed limit is 25 mph, 15 in the North and South Paddocks,** and agrees that unsafe or improper operation of the Unregistered Vehicle and/or any violation of regulations and instructions may, at the sole discretion of VIR, result in penalties against the owner and/or operator including, but not limited to, immediate impoundment of the Unregistered Vehicle, and loss of racing privileges for the day for a first offense and the season for the second offense.
